

Announcement Faculty of Graduate Studies, Mahidol University Mahidol University Senior Researchers 2014

The purpose of this announcement is to provide a definitive guideline for the assigned responsibilities and qualifications of "Mahidol University Senior Researchers" as per requirements established by the Faculty of Graduate Studies, Mahidol University 2013.

By the authority of the Regulation of Mahidol University on Graduate Studies 2013, regulation number 5 and the resolution from the meeting number 8/2013 of the Faculty of Graduate Studies Standing Committee on the 7th of August, 2013, this announcement here forth defines and specifies the responsibilities of "Mahidol University Senior Researchers" with regards to graduate studies as follows.

- 1. In this announcement, "Mahidol University Senior Researchers" are defined as an employee(s) of Mahidol University in the field of Academic Researcher.
- 2. "Mahidol University Senior Researchers" may assume the following responsibilities with regards to graduate studies.
 - 2.1 Lecturer
 - 2.2 Thesis/thematic paper proposal advisor
 - 2.3 Thesis/thematic paper proposal examiner
 - 2.4 Thesis/thematic paper major advisor
 - 2.5 Thesis/thematic paper co-advisor
 - 2.6 Comprehensive examination committee member of the Master's Degree program plan B
 - 2.7 Qualifying examination committee member of the Doctoral Degree program
 - 2.8 Thesis/thematic paper examiner

The responsibilities should not include: 1) faculty member of a program administrators 2) instructors in charge of a program 3) course coordinator.

3. "Mahidol University Senior Researchers" must have the qualifications that fulfill the responsibilities as follows.

4. Procedures for nominating "Mahidol University Senior Researchers" for the responsibilities related to graduate studies

The Administrative Program Committee of the relevant degree program will consider and approve the nomination of "Mahidol University Senior Researchers" who possess the required qualifications as per this announcement and submit to the Dean of the Faculty of Graduate Studies for endorsement to take the specified responsibilities.

5. In the event of any problems arising from the implementation of this announcement, the Dean of the Faculty of Graduate Studies reserves the right for the final decision.

The announcement is effective from the present date onwards.
