#### Admission Requirements

1. A candidate must have one of the two following main requirements :
  - 1.1 Candidates should have a Bachelor's degree or be studying in the last semester of Bachelor's degree in a Science, Engineering, or Social Sciences Programme in any discipline with ongoing experience or activities related to Environment.
  - 1.2 Candidates should have a Master's degree in any discipline within either a Science, or Engineering, or Social Sciences Programme.  
Experience doing research and being published in an international journal will be a good advantage.
2. have a minimum grade point average of 3.50
3. submit (3 copies) evidence of scholarly or professional attainments and show satisfactory research preparation to the Programme Committee;
4. have a TOEFL score of at least 500, TOEFL computer-based score of 173, TOEFL Internet-based score of 61, or IELTS score of 5.  
Those who do not have any of the test scores specified above will have to take the English Proficiency Examination of the Faculty of Graduate Studies on the specified examination day.

Exceptions from the above conditions may be granted by the Programme Committee under exceptional circumstances.

#### Registration

1. Students must register as full-time students.
2. The Programme Committee may recommend students take up to 9 credits of course-work in any subject offered by the Faculty of Environment and Resource Studies or other departments in Mahidol University without credit and the student has to attend at least 80% of the classes.
3. The Programme Committee will require students to present at least one paper per year in an academic conference or a public forum on an aspect of their research.
4. At the end of each academic year students will provide a detailed report to the Supervisory Panel on the progress made during that year, the progress expected to be made in the up coming year, and details of any problems associated with the research which have arisen or may arise. After reviewing the student progress, the Supervisory Panel will forward the report, with their own comments, to the Programme Committee which will confirm, suspend, or terminate the student's enrollment.

### Consideration Process

1. Consideration will be made based on reviewing of Concept Paper.  
Candidates must prepare 3 copies of concept paper for the interview.
2. Interview session will be July 2 - 4 , 2014.
