1. have a Master of Public Health (MPH) or Master of Science (M.S.) degree majoring in family health, environmental science, public health nursing, infectious disease and epidemiology, health promotion, public health administration; or its equivalent or related degree from accredited education institutes by the Office of Higher Education Commission
2. have a minimum grade point average of at least 3.50
3. have at least one year of working experience in public health or other related field after finishing the Master degree program
4. have a TOEFL score of at least 500, TOEFL computer-based score of 173, TOEFL Internet based score of 61, or IELTS score of 5.

Those who do not have any of the test scores specified above will have to take the English Proficiency Examination of the Faculty of Graduate Studies on the specified examination day.

5. In case your qualification does not match to the admission criteria, candidates must prior attach A Requesting Form for Examination” approved by the program director. The form must be submitted before making the application. Kindly download here:

Research Proposal Guideline Doctor of Public Health

Research Proposal: Write research proposal in the area of interest. This proposal may be a potential dissertation proposal for the doctoral program. The areas of interest should be congruent with the Department specially areas which the applicants can retrieve from the application manual.

The proposal includes:

1. Title (or cover) Page
2. Introduction (Background & Significance)
3. Statement of the problem/ Research question
4. Objective of the research, and/or Hypothesis
5. Expected benefit from this proposal
6. Review literature (including conceptual framework)
7. Research Method
8. References

The proposal should not exceed 5 pages in English. The proposal must be submitted with the application to the Secretary of the Public Health Doctoral Program no later than **(First Round) January 5, 2015** and **(Second Round) May 16, 2015**
